1.) Team A is granted a 60-second time-out. During the time-out, the coach has his/her players sitting on stools on the court between the sideline and free throw lane line. Following the time-out,

the referee informs the coach that time-outs must be held within the confines of the bench. Is the referee correct? YES or NO
